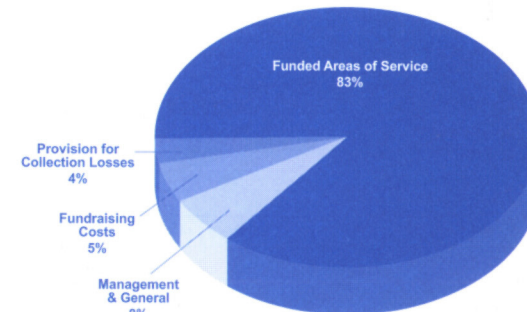


"Live United" in our community

- \$1 per week provides six sessions of education in infant care and safety for "at risk" young parents.
- \$3 per week provides a recently unemployed family of five with groceries for three weeks.
- \$5 per week provides one-on-one health insurance counseling for 17 seniors and their care-givers.
- \$10 per week provides four months of child care assistance for a single mother who is attending college.
